

# **SOCIAL MEDIA COMPETITION RULES**

**Official Rules.** NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS COMPETITION. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

**Participation Eligibility.** If you are an individual legal resident of the 50 United States or the District of Columbia and are 18 or older at the time of entry, you are eligible to enter the competition. Submissions from individuals under 18 years of age can be submitted, but a legal guardian will be required to receive the prize. You do not have to be a Five Points Bank customer to enter the contest.
