Linda's Delicious Dishes

Quick and easy Garlic Shrimp with Ramen Noodles

- 2 TB Olive Oil
 4 garlic Cloves, Minced
 1 pound of shrimp, peeled and deveined
 Salt and pepper to taste
 1 TB butter
 2 TB Olive Oil
 1 yellow onion sliced
 2 C broccoli florets
 2 packages (3 ounces each) shrimp
 flavored Raman noodles
 2 C chicken or vegetable broth
- -Cook garlic in a large nonstick skillet with 2 TB olive oil for 1 minute
 -Add shrimp and season with salt and pepper; cook 2 minutes on each side
 -Add butter, cook until butter is melted and shrimp is pink with brown edges.
 Transfer shrimp to a platter. Do not clean the skillet Return skillet to stove. Add 2 TB olive oil at Medium-high heat.
 -Add Onions and Broccoli, cook for 5 minutes.
 -Add broken noodles, broth and season packets. Stir.
 -Bring to a boil.
 -Cook and stir for about 5 minutes or until most of the liquid is absorbed.
 -Add shrimp last 2 minutes just to heat through
 -Removed from heat and let stand for a couple minutes.

I have also used frozen peas, bell peppers, mushrooms and carrots as vegetables.



2020 was an off year for many of us and not just because of Coronavirus. We took a one-year hiatus from Required Minimum Distributions and we changed the age at which required distributions must be started from your Individual Retirement Account (IRA) or workplace retirement plan such as a 401(k) or 403(b). The biggest change is that if you were born after July 1, 1949, you can wait to start taking required distributions until the year you turn 72.

So, if you turn 72 in 2021, what should you know? First, although you have until April 1st of 2022 to actually take the first required withdrawal, it may not be a good idea to wait that long. Why? Because then you will have to take two required distributions in one tax year.

After your first year of required distributions, all subsequent distributions must be taken before the end of the calendar year. So if you wait on your first one, you'll have two required distributions in 2022. Maybe it won't be a big deal depending on your tax situation, but it might have an impact to have double the income in one year.

The cost of not taking the distribution as required is pretty significant. There is a 50% penalty for the amount that you should have taken if you miss it. So, it is very important to make sure that you take all mandated distributions from traditional IRAs, 401(k)s, 403(b)s, and Roth 401(k)s. Only Roth IRAs are excused from the annual distribution requirement.

The time to think about required distributions is before you turn 72. We have many clients who may start distributions before age 72 either in cash or in the form of Roth conversions. Many people are sitting on large deferred balances, and while there is a benefit to not touching those tax-deferred assets because you can continue to enjoy tax-deferred growth, some individuals, given the size of their IRA or 401(k), can be subject to pretty large mandated distributions, which would then hit them with a big tax bill in the future. Yes, you are accelerating some tax liability, but if it's at a lower tax rate, and also lowering future required distributions, it might be a good idea.

Depending on your tax situation, it may make sense to start moving income you can have taxed into a low income year now, and then know that your future Roth IRA distribution either won't be required or, even if you take a distribution, it won't be taxed. Every year it's worth chatting with your tax advisor and considering whether or not a withdrawal or Roth conversion makes sense even if it's not required.

Required distributions from retirement accounts and determining when to start claiming Social Security benefits both offer us some flexibility for tailoring our choices to our personal circumstances. And while that flexibility can be important, it may also make the decisions more complicated. It is good to be thoughtful and it's a good time to have a conversation with a financial advisor like Casey, Allie or Bruce just to make sure you're making the best choices for your situation. What can a Trust do for You?



Trusts can provide a measure of comfort knowing that you have a plan in place to help provide for the safe and accountable management of family assets and to direct their use in accordance with your wishes, goals and objectives. Trusts are used to ensure the proper management of your assets at all three stages of your life:

Trusts can assure that funding is available for specific needs, such as education, health care or charitable interests. Trusts provide a framework in which money is managed in a predictable fashion, by persons you choose, according to standards you set. Trusts create guidelines for current and future distributions that reflect your wishes.
