Linda's Delicious Dishes CARAMEL PRETZEL BROWNIES

Ingredients

1 Box Betty Crocker Fudge Brownie mix Water, vegetable oil and eggs as called for on Brownie Mix Box
1 c semisweet chocolate chips
1 bag (14 oz) caramels
1/4 c butter or margarine
1 TB milk
1 c pretzels, coarsely crushed
1/3 c toffee bits

<u>Directions</u>

Heat oven to 350 degrees, (325 for dark and nonstick pan). Grease 9 x 13 pan

Make brownies as directed on box, stir in ½ c chocolate chips. Spread into pan, Bake 24-28 minutes.

Cool 5 minutes

While baking, microwave caramels, butter and milk on high 2-3 minutes, stirring once, until caramels are melted. Pour and spread over warm brownies, Sprinkle with pretzels, remaining ½ c chocolate chips and toffee bits.



Tax-Loss Harvesting Opportunities

While this year has been stressful and disappointing in terms of investment growth, keep in mind that even the best investors will suffer losses from time to time. Even the briefest review of market history will show periods where the results mimic current returns even if the causes were different. One way to take advantage of such periods is the use of tax-loss harvesting.

In general, tax-loss harvesting takes advantage of losses in your portfolio to offset current and future taxable gains. And while tax-avoidance strategies should not dictate your investment strategy, it is a chance to make some lemonade out of the lemons we've been handed this year in particular.

The basics of a tax-loss harvesting hypothetical example go like this: You have an investment where your original investment and current tax basis is \$10,000. Its current market value is \$8,500 and would trigger a \$1,500 loss if you sold it today. Assuming your investment objectives have not changed since that original investment, you identify an alternative investment that you believe will provide similar performance to your original choice, sell your current holding and reinvest the proceeds in the alternative. You haven't changed your investment objective or results, but now you have a \$1,500 loss that may be used to offset other gains, or possibly even a small amount of earned income and reduce your total tax liability for this year. Harvested losses not used to offset gains can be used to offset up to \$3,000 of income per year.

Why do you need to have a conversation with a tax professional? First, it may not be possible to find a reasonable alternative and you need to be familiar with the full range of outcomes and rules that accompany tax-loss harvesting.

Although the Internal Revenue Service provides somewhat ambiguous definitions, investors are not allowed to deduct losses from sales of securities in a "wash sale." According to the IRS, a wash sale occurs when you sell securities at a loss, and within 30 days before or after the sale, you do the following: Buy substantially identical securities, acquire substantially identical securities in a fully taxable trade, or acquire a contract or option to buy substantially identical securities. For more information, see IRS publication 550 and consult your tax advisor.

Short-term dips in performance present us with the opportunity to potentially take advantage of the losses through tax-loss harvesting. However, your primary goal should not be to avoid taxes. Investors should look to participate in securities that they believe will appreciate in value and build prudent long-term allocations. Why must an estate be probated and can it be avoided?

If you die with any property titled in your personal name, there must be a legal procedure (assuming the estate is above a minimum size) for handling two major functions of your estate. (1) Identification of the rightful heirs to

the estate and their share size that each heir will receive, and (2) getting the legal title of the property out of the name of the deceased and into the name of the heir or heirs. Having a will drafted in advance of your death will take care of the first function, identification of the rightful heirs and their share. But even with a will the re-titling of your property must be handled through a court administered procedure.. Probate. One way to avoid probate is to create a Revocable Trust with you as the initial trustee. Assets that are in the trust will pass to the heir as directed and the court involved probate procedure can be avoided.






