2026 Nebraska State Fair Ticket Giveaway Sweepstakes

Official Rules

NO PURCHASE, APPLICATION, OR USE OF SPONSOR PRODUCTS OR SERVICES IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. ELIGIBILITY

The Nebraska State Fair Ticket Giveaway Sweepstakes (“Sweepstakes”) is open to legal residents of Nebraska who are 18 years of age or older at the time of entry.

Employees of Five Points Bank and their immediate family or household members are not eligible to enter.

By participating, entrants agree to be bound by these Official Rules and the decisions of the Sponsor, which are final and binding.

2. SWEEPSTAKES PERIOD

The Sweepstakes begins at 12:00 p.m. Central Time (“CT”) on Friday, August 21, 2026, and ends at 8:00 a.m. CT on Wednesday, August 26, 2026.

Entries received before or after the Sweepstakes Period will not be eligible.

3. HOW TO ENTER

During the Sweepstakes Period, eligible individuals may enter by completing all of the following actions on the Nebraska State Fair Ticket Giveaway post published on Five Points Bank's official Facebook page:

- React to the giveaway post.
- Comment on the giveaway post.
- Like or follow Five Points Bank's official Facebook page.

Limit one (1) entry per person. Completing any action more than once will not increase an entrant's chances of winning.

The entrant must be the authorized holder of the Facebook account used to enter. Entries must be publicly visible to the Sponsor. Entries that cannot be viewed because of privacy settings or other restrictions may be deemed ineligible.

4. DRAWING AND WINNER ANNOUNCEMENT

One (1) potential winner will be selected in a random drawing from among all eligible entries received during the Sweepstakes Period.

The drawing will be conducted on or about Wednesday, August 26, 2026, under the direction of the Sponsor, whose decisions are final.

The confirmed winner is expected to be announced on Five Points Bank's official Facebook page at approximately 12:00 p.m. CT on Friday, August 28, 2026. The announcement may be delayed if additional time is needed to confirm eligibility or contact an alternate winner.

5. ODDS

The odds of winning depend on the total number of eligible entries received.
