



Valentine's Day Giveaway Sweepstakes

Official Rules

NO PURCHASE, APPLICATION, OR USE OF SPONSOR PRODUCTS OR SERVICES NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. ELIGIBILITY

The Valentine's Day Giveaway Sweepstakes ("Sweepstakes") is open to legal residents of the State of Nebraska who are eighteen (18) years of age or older at the time of entry. Employees of Five Points Bank and members of their immediate household are not eligible.

By participating, entrants agree to be bound by these Official Rules and Sponsor's decisions, which are final. The Sweepstakes is subject to all applicable federal, state, and local laws. Void where prohibited.

2. SWEEPSTAKES PERIOD

The Sweepstakes begins at 9:00 am CT on February 3rd and ends at 11:59:59 p.m. CT on February 9th, 2026 ("Sweepstakes Period").

3. HOW TO ENTER

During the Sweepstakes Period, individuals may enter the Sweepstakes by commenting on the and reacting to the Valentine's Day Giveaway post displayed on Five Points Bank's official Facebook page. They also must like Five Points Bank official Facebook page.

Limit one (1) entry per person, regardless of the method of entry selected. Completing more than one action will not increase the chances of winning.

The entrant must be the authorized holder of the associated Facebook account. Entries must be publicly visible to Sponsor; entries that cannot be viewed due to privacy settings will be deemed ineligible.

4. DRAWING

One (1) potential winner will be selected in a random drawing from among all eligible entries received during the Sweepstakes Period. The drawing will be conducted on or about February 10, 2026, under the direction of Sponsor, whose decisions are final.

5. ODDS

The odds of winning depend on the total number of eligible entries received.
